Good morning Jason,

I have tried to call a few times this morning but the call seems to keep failing. I wanted to discuss the below with you.

Last year, Deloitte joined with a firm called Yamagigu Consulting. They are the largest First Nations consulting business in Australia. I have spoken with my colleagues there who are administering a program called, First Nations Tourism Mentoring Program (FNTMP). This is a program for Aboriginal Tourism businesses that provides free mentoring support for up to 300 hours for eligible businesses. The link to the program is here: <https://www.fntmp.com.au/s/>. An initial assessment shows we believe your business would be eligible.

Through this program, you are provided with experienced mentors who can assist you with business advice, including assisting you with updating your business plan. Is this something you would be interested in? If so, can you please confirm you are comfortable for me to provide your details to the administrators, and they will contact you to commence the process?

This would then allow you to apply for the grant with NTG for \$30k and apply this against the equipment you wish to purchase for the lawn mowing side of your business (which would not fall within the Tourism program) and your computer and software upgrades. You could reach out to Jodie Stevens at your convenience and begin this process.
